## THE RURAL MUNICIPALITY OF WHITEMOUTH

## BY-LAW NO. 737/22

BEING A BY-LAW OF THE RURAL MUNICIPALITY OF WHITEMOUTH TO ESTABLISH AND AUTHORIZE PAYMENT OF INDEMNITIES AND EXPENSES WHILE ATTENDING MUNICIPAL BUSINESS TO BE PAID TO THE MEMBERS OF COUNCIL.

WHEREAS Section 124(2) of The Municipal Act C.C.S.M. c.M225 58 provides as follows:

124(2) A council may by by-law set the types, rates and conditions of payments to be made to or on behalf of members of the council and council committees, other than the committee of a local urban district,

- (a) as compensation for attending to municipal business;
- (b) for expenses incurred while attending to municipal business; and
- (c) for any other purpose relating to municipal business that the council considers appropriate.

**AND WHEREAS** it is deemed expedient and in the best interests of the residents of The Rural Municipality of Whitemouth to provide for the payment of indemnities, mileage and other remuneration incident to the discharge of such duties as a member of council;

**NOW THEREFORE** the Council of The Rural Municipality of Whitemouth, duly assembled, enacts as follows:

1. THAT remuneration of members of council shall be as follows:

(a) monthly in

- (b) That the remuneration in 1(a) shall include all regular council meetings.
- (c) That each member of council duly authorized to perform work or service on behalf of the municipality that requires travel away from the municipality in the performance of the duties of his/her office shall be paid as follows:
  - i. For meetings in and beyond the boundaries of the municipality, including travel time:
    \$23.00 per hour or daily per diem \$184.00

- ii. Meal costs to be reimbursed as receipts supplied from Council.
- iii. A rate of \$ 0.60 per kilometer for each kilometer traveled for the use of a private vehicle owned or operated by a member of council in performance of his/her duties.

- (e) That there be a minimum meeting charge equivalent to two hours time at the rates set out in paragraph c(i) above.
- 2. **THAT** all claims for remuneration and mileage shall be submitted by no later than 90 working days after month end
- 3. THAT this by-law shall come into effect on November 1, 2022; and
- 4. **THAT** this by-law supersedes any other by-laws setting rates of pay for Reeve, Deputy Reeve and Councillors of the Rural Municipality of Whitemouth.
