

**THE RURAL MUNICIPALITY OF WHITEMOUTH**

**BY-LAW NO. 691/19**

BEING A BY-LAW OF THE RURAL MUNICIPALITY OF WHITEMOUTH TO ESTABLISH AND AUTHORIZE PAYMENT AT OF INDEMNITIES AND EXPENSES WHILE ATTENDING MUNICIPAL BUSINESS TO BE PAID TO THE MEMBERS OF COUNCIL.

**WHEREAS** Section 124(2) of The Municipal Act S.M. 1996, c. 58 provides as follows:

124(2) A council may by by-law set the types, rates and conditions of payments to be made to or on behalf of members of the council and council committees, other than the committee of a local urban district,

- (a) as compensation for attending to municipal business;
- (b) for expenses incurred while attending to municipal business; and
- (c) for any other purpose relating to municipal business that the council considers appropriate.

**AND WHEREAS** it is deemed expedient and in the best interests of the residents of The Rural Municipality of Whitemouth to provide for the payment of indemnities, mileage and other remuneration incident to the discharge of such duties as a member of council;

**NOW THEREFORE** the Council of The Rural Municipality of Whitemouth, duly assembled, enacts as follows:

1. **THAT** remuneration of members of council shall be as follows:

(a) Head of Council

The total annual remuneration for the Reeve shall be the sum of \$ 9,072.00.  
\$ 756.00 per month

(b) Councillors

The total annual remuneration for each Councillor shall be the sum of \$ 7,128.00.  
\$ 594.00 per month


(c) That the remuneration in 1(a) and 1(b) shall include all regular council meetings.


(d) That each member of council duly authorized to perform work or service on behalf of the municipality that requires travel away from the municipality in the performance of the duties of his/her office shall be paid as follows:

- i. For meetings in and beyond the boundaries of the municipality, including travel time:  
\$ 19.50 per hour
- ii. Meal costs to be reimbursed as receipts supplied from Council.

- iii. A rate of \$ 0.50 per kilometer for each kilometer traveled for the use of a private vehicle owned or operated by a member of council in performance of his/her duties.
- (e) That there be a minimum meeting charge equivalent to two hours time at the rates set out in paragraph d(i) above.
- 2. **THAT** all claims for remuneration and mileage shall be submitted by no later than 5 working days after month end
- 3. **THAT** this by-law shall be retroactive to January 1, 2019; and
- 4. **THAT** this by-law supersedes any other by-laws setting rates of pay for Reeve, Deputy Reeve and Councillors of the Rural Municipality of Whitemouth.
